#### SECTION 4: FIRST AID MEASURES

##### Description of first aid measures

## SECTION 5: FIRE FIGHTING MEASURES

### ADDITIONAL TOXICOLOGY INFORMATION:

This product contains ethylene glycol. The toxicity of ethylene glycol via inhalation or skin contact is expected to be slight at room temperature. The estimated oral lethal dose is about 100 cc (3.3 oz.) for an adult human. Ethylene glycol is oxidized to oxalic acid which results in the deposition of calcium oxalate crystals mainly in the brain and kidneys. Early signs and symptoms of ethylene glycol poisoning may resemble those of alcohol intoxication. Later, the victim may experience nausea, vomiting, weakness, abdominal and muscle pain, difficulty in breathing and decreased urine output. When ethylene glycol was heated above the boiling point of water, vapors formed which reportedly caused unconsciousness, increased lymphocyte count, and a rapid, jerky movement of the eyes in persons chronically exposed. When ethylene glycol was administered orally to pregnant rats and mice, there was an increase in fetal deaths and birth defects. Some of these effects occurred at doses that had no toxic effects on the mothers. We are not aware of any reports that ethylene glycol causes reproductive toxicity in human beings.
